#### **Construction Design Management**

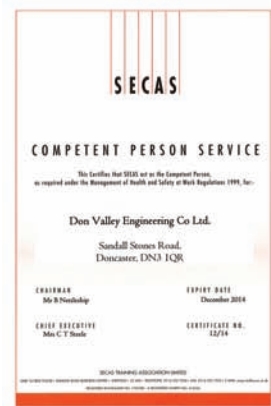
